

The public is relying on television news for updates during the coronavirus pandemic, but not all viewers are getting the same story. Our <u>study</u> reveals that coverage of the virus is politicized in ways that seem to put profit and partisanship above public health, particularly on Fox News and MSNBC.

As part of this report, we've gathered information about the networks' board members and shareholders. These individuals and organizations knowingly or unknowingly condone politicized coverage. If you find the coverage troubling, you can contact them to advocate for change.

This document outlines the board members and top shareholders of the parent companies of FOX News and MSNBC. Below you will find information on the common stock for each respective company — preferred stock was not included. Parent companies are as follows:

- **FOX News** is housed within Fox Corporation, which has two classes of common stock: Class A Non-Voting Common Stock and Class B Voting Common Stock (NYSE: FOXA, FOX).
- **MSNBC** is part of a NBCUniversal News Group, which is owned by Comcast Corporation.¹ Comcast Corporation has two classes of common stock: Class A Common Stock and Class B Common Stock (NYSE: CMCSA).

METHODS

These lists were compiled using Morningstar Investment Research Center and PitchBook Financial Databases, two platforms used by investors and researchers to access data on public and private companies. Data used from these platforms came from 13F filings reported on September 30, 2020. 13F filings are quarterly reports required by the U.S. Securities and Exchange Commission for all institutional investment managers with "investment discretion over \$100 million or more in Section 13(f) securities)." Among other items, each filing discloses the number of shares held in a company and the market value.

Our research supplemented these reports with information from Comcast Corporation and Fox Corporation's DEF 14A SEC filings, which are forms required to be submitted whenever a shareholder vote is mandatory.⁸ In particular, the forms referenced in this research were each of the companies' "2020 Notice of Annual Meeting of Stockholders." These forms outline persons security ownership of Directors, Nominees, and Executive Officers, which pertains specifically to the Murdoch Family Trust and Brian L. Robert's ownership of Class B Stock.
